SERVICE ORDER PART-I NO. 30 / 2019

Subject:- **PROMOTION-CUM-POSTING FROM SI/EXE TO THE RANK OF INSP/EXE ON REGULAR BASIS AGAINST THE YEAR -2019 : (INSP/EXE PANEL NO.01/2019), PANEL STRENGTH-200)**

The SIs/Exe mentioned in Appendix – 'A' are promoted to the rank of Inspector (Exe) on regular basis and posted to the Sectors as shown against their names. Sector IsG will allot them unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume charge as Insp/Exe in the new place of posting:-

2. Before promoting them, it should be ensured that they fulfill the following conditions: -

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of Inspector/Exe.
- iii) They should have been in medical category Shape-I before being declared fit by the DPC's and if there is any deterioration in the medical categorization of an empanelled SI/Exe after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No.660 dated 17.09.2018, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after regaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2019. In case, he/she does not regain Shape-I medical categorization by 31.12.2019, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/Criminal Proceedings are pending/contemplated against them.
- v) Promotion should not be given, in case an empanelled SI/Exe is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled SI/Exe is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQ (Estt.I Branch) for deletion of his/her name from the panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

3. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) accordingly.

4. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.

5. **The promotion of SIs/Exe to the rank of Insp/Exe is subject to Judgement Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP (C) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.**





6. In case, any of the SI/Exe mentioned in Appendix –‘A’ have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector IsG from the **present place** of posting under intimation to this Dte. However, in case any of the individual has been posted out to another **Sector repeat another Sector**, cases of such personnel may be taken up with this Dte for amendment of PCP.

7. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of Insp/Exe in the new unit. In the promotion order it may be mentioned that Govt. Servant has to exercise the Option within one month for fixation of his pay under FR-22.

8. All Sector IsG are requested to ensure that there is minimum movement of personnel on PCP. As far as possible affected personnel retained in the same sector may be adjusted in the same unit if they have not completed their unit tenure except on extreme operational/administrative ground.

9. Compliance report along with charge assumption report will be forwarded to Estt-I Branch of this HQrs latest by 15/03/2019.
