**SERVICE ORDER PART-I NO. 29 / 2019**

Subject:- **PROMOTION-CUM-POSTING FROM HC(DVR) TO THE RANK OF ASI/MT ON REGULAR BASIS AGAINST THE YEAR -2019 : (ASI/MT PANEL NO.01/2019), PANEL STRENGTH-196)**

The HCs(Dvr) mentioned in Appendix – ‘A’ are promoted to the rank of Assistant Sub Inspector (MT) on regular basis and posted to the Sectors as shown against their names. Sector IsG will allot them unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume charge as ASI/MT in the new place of posting:-

2. Before promoting them, it should be ensured that they fulfill the following conditions: -

- a) They are confirmed in the entry grade;
- b) They have successfully completed the promotion cadre course of ASI (MT);
- c) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled HC after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 3(d) of CISF HQrs letter No.514 dated 11.07.2017, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2019. In case, he/she does not re-gain SHAPE-I medical categorization by 31.12.2019, his/her case will be considered afresh by the next DPC;
- d) No DE/Vigilance/ Criminal proceeding are pending/ contemplated against any of them;
- e) Promotion should not be given, in case an empanelled HC(Dvr) is awarded any punishment after the DPC and before his/her actual promotion. If any empanelled HC(Dvr) is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FI'Q (Estt.I Branch) for deletion of his/her name from the panel as well as cancellation of PCP;
- f) Promotion should also not be given during the currency of punishment, if any;
- g) In case the individual belongs to SC or ST category, it should be ensured that a certificate of SC or ST category issued by the appropriate authority is available in his service records. After verifying the same only the concerned individual be promoted/ relieved on promotion-cum-posting to the concerned unit;
- h) The promotion is without prejudice to the claim of other HCs(Dvr) whose formal order for promotion to the rank of ASI/MT are being issued separately. Their inter-se-seniority will be in order of panel drawn by the DPCs;
- i) Before relieving/ promoting the HCs/Dvr, the Seniority List may be checked thoroughly. Further, ensure that they have not been allotted with any double PSL numbers;

03. In case any of them is un-willing to move on promotion-cum-posting, a certificate (duly countersigned by competent authority) should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt-I Branch) without delay.

04. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.


05. The promotion of HC/Dvr to ASI/MT. is subject to order passed on 26.09.2018 by the Hon'ble Supreme Court in SLP(C) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.

06. In case, any of the HC/(Dvr) mentioned in Appendix -'A' have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector IsG from the **present place** of posting under intimation to this Dte. However, in case any of the individual have been posted out to another **Sector repeat another Sector**, cases of such personnel may be taken up with this Dte for amendment of PCP.

07. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of ASI/MT in the new unit. In the promotion order it may be mentioned that Govt. Servant has to exercise the Option within one month for fixation of his pay under FR-22.

08. All Sector IsG are requested to ensure that there is minimum movement of personnel on PCP. As far as possible affected personnel retained in the same sector may be adjusted in the same unit if they have not completed their unit tenure except on extreme operational/administrative ground.

09. Compliance report along with charge assumption report will be forwarded to Estt-I Branch of this HQrs latest by 15/03/ 2019.
