

बिषय: **PROMOTION-CUM-POSTING FROM ASI/FIRE(LAB) TO THE RANK OF SI/FIRE(LAB) FOR THE YEAR -2019.**

The ASI/Fire(Lab) mentioned in Appendix-"A" are promoted to the rank of SI/Fire (Lab) on regular basis in the pay Matrix of Rs.35400-112400 (for GP-4200,level 6) and posted to the Sectors as shown against their names. Sector IsG will allot them Unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume the charge as SI/Fire in their new place of posting.

02. Before promoting them, it should be ensured that they fulfill the following conditions :-

i)	They are confirmed in the entry grade or in the present rank.
ii)	They have successfully completed the promotion cadre course of <b>SI/Fire.</b>
iii)	They should have been in medical category SHAPE-I before being declared FIT for promotion by the DPC and if there is any deterioration in the medical categorization of the above empanelled ASI/Fire (Lab), after the DPC and before their actual promotion, the promotion will be withheld. <b>Further, as per MHA's directions dated 27.04.2012, incorporated in Para 2 [d] of CISF HQrs, letter No. 130 dated 19.02.2019, any person who has been declared FIT by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after re-gaining their SHAPE-I medical categorization, before completion of vacancy year i.e. not later than 31.12.2019. In case they do not re-gain SHAPE-I medical categorization by 31.12.2019 their cases will be considered afresh by the next DPC.</b>
iv)	No Disciplinary/Vigilance/legal proceedings are pending/contemplated against them.
v)	Promotion should not be given, in case an empanelled ASI/Fire (Lab) is awarded any punishment after the DPC and before his actual promotion. If an empanelled ASI/Fire (Lab) is awarded any punishment after the DPC and before his actual promotion, the matter be referred to FHQ (Estt.I Branch) for deletion of his name from the panel as well as cancellation of PCP.
vi)	Promotion should also not be given during currency of punishment if any.




vii)	In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their documents.
viii)	In case anyone is unwilling to move on promotion due to his own reason, a certificate to this effect (duly signed by the authority concerned that he is willing to forgo his promotion and will not claim for seniority) may be obtained and forwarded to his HQrs (Estt.I Section) .

3. The Unit Commandants (Appointing Authority) will issue Unit Service Order Part-I indicating the PSL Number of ASI/Fire (Lab) and date of promotion/assumption of charge in the rank of SI/Fire & will invariably forward copies of the S.O. Part-I to this HQ (Estt-I/Estt-II and Tech Branch). In the promotion order, it may be mentioned that Govt. Servant has to exercise the option within one month for fixation of his pay under FR-22.

4. The promotion of above ASI/Fire (Lab) is subject to Judgment Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP (C ) No. 30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No. 36012/11/2016-Estt. (Res-I) (Pt-II) dated 15.06.2018.

5. In case, any of the ASI/Fire (Lab) mentioned in Appendix 'A' have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector IsG from the **present place** of posting under intimation to this Dte. However, in case any of the individual has been posted out to another **Sector repeat another Sector**, cases of such personnel may be taken up with this Dte for amendment of PCP.

6. All affected personnel may be relieved immediately and a consolidated compliance report may please be submitted to this Dte by **10.07.2019**.
