**SERVICE ORDER PART-I NO. 09 / 2019**

Subject : **PROMOTION-CUM-POSTING FROM HC(FIRE) AND HC(DCPO) TO THE RANK ASI(FIRE/LAB) ON REGULAR BASIC FOR THE YEAR-2019 (PANEL NO.01/2019 PANEL STRENGTH-180).**

The HC/Fire and HC/DCPO mentioned in **Appendix –“A”** are promoted to the rank of Assistant Sub Inspector(Fire) on regular basis in the pay matrix of Rs.29200-92300(for GP-2800, level-5) and posted to the Sectors as shown against their names. Sector IsG will allot them Unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume the charge as ASI(Fire) in their new place of posting:-

2. Before promoting them, it should be ensured that they fulfill the following conditions:-

- (a) They are confirmed in the entry grade or in the present rank.
- (b) They have successfully, completed the promotion cadre course of ASI/Fire/Lab.
- (c) They should have been in medical category SHAPE-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled HC/Fire & HC/DCPO after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in **Para 2 [d] of CISF HQrs, letter No. 659 dated 17.09.2018, any person who has been declared FIT by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after re-gaining his/her SHAPE-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2019. In case he/she does not re-gain the SHAPE-I medical categorization by 31.12.2019, his/her case will be considered afresh by the next DPC.**
- (d) No DE/Vigilance/Criminal proceedings are pending/contemplated against them.
- (e) Promotion should not be given, in case an empanelled HC/Fire & DCPO is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled HC/Fire & DCPO is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQ(Estt.I Branch) for deletion of his/her name from the panel as well as cancellation of PCP.

- (f) Promotion should also not be given during the currency of punishment, if any.
- (g) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.


03. In case any of them is unwilling to move on promotion-cum-posting, a certificate should be obtained from concerned person that he is willing to forego his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs (Estt.I) Branch ) accordingly.

04. The promotion of HC/Fire & DCPO to ASI/Fire/Lab), is subject to Judgment Order dated 26.09.2018 of Hon'ble Supreme Court of India in SLP( C ) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No. 36012/11/2016/Estt.I (Res.I) (Pt-II) dated 15.06.2018.

05. In case, any of the HC/Fire & HC/DCPO mentioned in Appendix 'A' have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector IsG from the **present place** of posting under intimation to this Dte. However, in case any of the individual have posted out to another **Sector repeat another Sector**, cases of such personnel may be taken up with this Dte for amendment of PCP.

06. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of ASI/Fire in new unit. In the promotion order if may be mentioned that Govt. Servant has to exercise the option within one month for fixation of his pay under FR-22.
