SERVICE ORDER PART-I NO. 149/2019

SUBJECT: PROMOTION-CUM-POSTING FROM CONSTABLE(GD) TO THE RANK OF HEAD CONSTABLE(GD) ON REGULAR BASIS FOR THE YEAR -2019

The Constable/GD mentioned in Appendix-A, who have been found fit by the left out DPC-2019 and empanelled for promotion to the rank of Head Constable/GD on regular basis in the pay scale of Rs. 5200-20200 +GP 2400(PB-1) (Now at level 4 in the new Pay Matrix 25500-81100) are promoted to the rank of Head Constable/GD on regular basis and posted to the same Sector in which they are serving against the available vacancies and wherever surplus, against the higher vacancy. Sector IsG are requested to adjust them in the present unit as far as possible and their posting to OHS/HS as due will be considered in IST-2020. Their promotion will take effect from the date they assume the charge as Head Constable/GD.

02. Before promoting them, it should be ensured that they fulfill the following requirements:

- a) They are confirmed in the entry grade or in the present rank.
- b) They have successfully completed the Promotion Cadre Course of HC/GD.
- c) They should have been in medical category SHAPE-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled Constable/GD after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in Para-2(d) of CISF HQr letter No.660 dated 17.09.2018, any person who has been declared fit by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after regaining his/her SHAPE-I medical categorization, before completion of vacancy year i.e not later than 31.12.2019. In case, he/she does not regain SHAPE-I medical categorization by 31.12.2019, his/her case will be considered afresh by the next DPC.
- d) No DE/Vigilance/criminal proceedings are pending against them.
- e) Promotion should not be given, in case an empanelled Constable/GD is awarded any punishment after the DPC and before his / her actual promotion. If an empanelled Constable/GD is awarded any punishment after DPC and before his/her actual promotion, the matter be referred to FHQrs (Estt.I& II) for deletion of his/her name from the panel as well as cancellation of his PCP.

- f) Promotion should also not be given during the currency of punishment , if any.
- g) In the case of SC / ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.
- h) In case any of them is unwilling for promotion due to his own volition, a certificate should be obtained from the concerned person that he is willing to forego his promotion and will not claim promotion and seniority later on and same, may be forward to this HQrs(Estt.I) accordingly..
- i) The charge assumption report and service order Part-I regarding promotion may be submitted to this Hqr (Estt-I branch) by the concerned units and appointing authority respectively, immediately on assumption of their charge.
- j) The promotion of Const/GD to the rank of HC/GD against the year 2019 is subject to **the order passed by the Hon'ble Supreme Court on 26.09.2018 in SLP© No. 30621/2011 and further orders which may be passed by the Hon'ble Supreme Court as mentioned in the DoPT OM No.F- No.36012/11/2016-/Estt(Res-I)(Pt-II) dated 15.06.2018**

3. In the promotion order, it may be mentioned that Govt. Servant may exercise the option within one month for fixation of his pay under FR -22.

4. In case, the Const/GD mentioned above have been posted out to another unit in the same sector, his promotion-cum-posting may be issued by the concerned Sector IsG from the **present place** of posting under intimation to this Dte. However, in case the individual has been posted out to another **Sector repeat another Sector**, the cases of such personnel may be taken up with this Dte for amendment of PCP.

- d) No DE/Vigilance/Criminal proceedings are pending/contemplated against them.
- e) Promotion should not be given, in case an empanelled Constable/Dvr is awarded any punishment after the DPC and before their actual promotion. If an empanelled Constable/Dvr is awarded any punishment after DPC and before their actual promotion, the matter be referred to FHQrs (Estt.I& II) for deletion of their name from the panel as well as cancellation of their PCP



- f) Promotion should also not be given during the currency of punishment, if any.
- g) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.
