Sub:- PROMOTION-CUM-POSTING FROM HC/MIN TO THE RANK OF ASI/CLK
FOR THE YEAR-2019 (PANEL STRENGTH -63 (PANEL NO.01/2019)

The HC/Min mentioned in Appendix-A are found fit by the regular DPC for the year 2019. They are promoted to the rank of Asstt Sub-Inspector (Clk) on regular basis in the pay scale of Rs.5200-20200+GP 2800 (PB-1) (Now at Level 5 in the New Pay Matrix, Rs.29,200-92,300) and posted to the Sectors/Units as shown against their names. They may be adjusted against similar rank or higher rank. Their promotion will take effect from the date(s) they assume charge as ASI/Clk in the new place of posting.

2. Before promoting them, it should be ensured that they fulfill the following conditions:

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of ASI/Clk.
- iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled HC/Min after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2 (d) of CISF HQrs letter No.660 dated 17.09.2018, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2019. In case, he/she does not re-gain Shape-I medical categorization by 31.12.2019, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/Criminal Proceedings are pending against them.
- v) Promotion should not be given, in case an empanelled HC/Min is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled HC/Min is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FHQ (Estt.I Branch) for deletion of his/her name from the promotion panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

3. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) accordingly.


4. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.

5. The promotion of HCs/Min to the rank of ASI/Clk is subject to Judgment Order dated 26.09.2018 of Hon'ble Supreme Court of India in SLP (C) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.

4. In case, any of the HC/Clk mentioned above have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, case of such personnel may be taken up with this Dte for amendment of PCP.

6. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of ASI/Clk in the unit.

Subject : **PROMOTION-CUM-POSTING FROM CONSTABLE/FIRE TO THE RANK OF HEAD CONSTABLE (FIRE) ON REGULAR BASIS FOR THE YEAR -2019.**

The Constable/Fire mentioned in Appendix –“A” who have been found fit by the regular DPC-2019 and empanelled for promotion to the rank of Head Const/Fire in the pay matrix of Rs.25500-81100 (for GP-2400, level-4) are promoted to the rank of HC/Fire on regular basis and posted to the Sectors as shown against their names. Sector IsG will allot them Unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume the charge as HC(Fire) in their new place of posting:-

2. Before promoting them, it should be ensured that they fulfill the following requirements:-

- (a) They are confirmed in the entry grade or in the present rank.
- (b) They have successfully, completed the promotion-cadre course of HC/Fire.
- (c) They should have been in medical category SHAPE-I before being declared fit by the DPC's and if there is any deterioration in the medical categorization of an empanelled CT/Fire after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in Para 2 [d] of CISF HQrs, letter No. 659 dated 17.09.2018, any person who has been declared FIT by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after re-gaining his/her SHAPE-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2019. In case he/she does not re-gain the SHAPE-I medical categorization by 31.12.2019, his/her case will be considered afresh by the next DPC. Personnel who have been declared SHAPE-II (LMC) at the time of DPC and their SMB is due during 2019, may be conducted on due date.
- (d) No DE/Vigilance/Criminal proceedings are pending against them.
- (e) Promotion should not be given, in case an empanelled Constable/Fire is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled Constable/Fire is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQrs (Estt.I Branch) for deletion of his/her name from the panel as well as cancellation of PCP.

- (f) Promotion should not be given during currency of punishment.
- (g) In the case of SC/ST officer, a certificate to this effect in prescribed format from the competent authority is available in their service documents.
- (h) If case any of them is un-willing to move on promotion-cum-posting, a Prescribed certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQRs (Estt.I Branch) accordingly.
3. The charge assumption report and service order Part-I regarding promotion may be submitted to this Dte (Estt.I Branch) by the concerned units and appointing authority respectively immediately on their assumption of Charge.
4. The promotion of CT/Fire to the rank of Head Constable/Fire is subject to Judgement Order dated 26.09.2018 of Hon`ble Supreme court of India in SLP (C) No.30621/2011 and further orders which may be passed by the Hon`ble Supreme Court, as mentioned in DoPT OM No.36012/11/2016-Estt.(Res.I){Pt-II} dated 15.06.2018.
5. In case, any of the Constable/Fire mentioned in Appendix-'A' have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector IsG from the present place of posting under intimation to this Dte. However, in case any of the individuals have been posted out to another Sector repeat another Sector, cases of such personnel may be taken up with this Dte for amendment of PCP.
6. All affected personnel may be relieved immediately and a consolidated compliance report may please be submitted by 30.11.2019 by the concerned Sector IsG.
